**ORDER**

As per the decision of the 41<sup>st</sup> Executive Committee meeting of C-DIT (Para 41.16.1) and Order No. Estt/IKM/CFAAG3/3684/2000 Dated 27.10.2000, Shri. Anvar Sadat.K was appointed as consultant in the Information Kerala Mission at a consolidated remuneration of Rs. 14,313/- Subsequently his post was re-designated as Senior Project Associate. and Head Implementation.

Based on his request, Shri.Anvar Sadat then Head (Implementation) was relieved from Information Kerala Mission on 30.06.2005 and was sanctioned LWA for 3 Years and for taking up an assignment in the Kerala State IT Mission as Manager (e-governance).

While continuing in service at KSITM, vide G.O(Rt)No.3359/2001/G.Edn dated 21.07.2007 Shri. Anvar Sadat was posted as Executive Director at IT @ School. Based on his request and as approved by the Executive Committee of IKM, his LWA was extended for a further period of 3 years ending 30.06.2011, with provision for returning to IKM any time during the Mission Project period.

Further, based on his request dated 23<sup>rd</sup> June 2011, the 53<sup>rd</sup> Executive Committee of IKM vide item No, 53.9, extended his LWA for a further period of two years, ending 30.06.2013.

Vide GO (Rt)No.1890/2012/G.Edn. dated 21.04.2012 on relinquishing from the services from the IT @ School, vide his letter dated 16.07.2012 Shri Anvar Sadat expressed his willingness to rejoin IKM with effect from 16.07.2012 after cancelling his LWA.

In the context that the 20<sup>th</sup> Executive Committee of IKM approved Shri. Anvar Sadat return to IKM anytime during the Mission project period, his request is accepted and he is permitted to join IKM on 16.07.2012. Temporarily Shri. Anvar Sadat will hold the charge of Director (Implementation) till the new incumbent joined the post.

Director (Technical) Shri Abdul Khalam Azad has forwarded his request to relieve him from the services of IKM w.e.f 10.08.2012. on Shri. Abdul Khalam, relinquishing his services from IKM, Shri.Anvar sadat will assume charge as Director (Technical).

Other service condition including pay and allowances will be as per the existing norms of IKM rules. The above order is subject to ratification by the Executive Committee.

This order comes into effect from 16.07.2012
